LUNDY'S When visiting Lundy remember that the needs of the island must come first. Help us keep Lundy special and leave the island as you find it – if not better!

- Don't drop litter. Pick up any you see and report pollution incidents to the Warden
- Dispose of cigarette butts and chewing gum in the bin – they harm wildlife
- Some plants like 'Lundy Cabbage' are rare. Never pick flowers, remove plants or take animals
- Collecting firewood or lighting campfires is not allowed anywhere
- Help preserve our historic sites which include 43 scheduled monuments.
 Don't climb the stone walls or disturb stones, gravestones or ruins – some are protected by law
- Abide by the climbing and scrambling restrictions in place during the seabird breeding season from 1st April to 31st August (ask for details)
- Lundy is rat free and we must keep it that way. Check your boats and bags as they can harbour rats. Take ALL rubbish home especially perishable foods and picnic leftovers.






Respect, Protect, Enjoy!









On the seashore...

• Leave animals where you find them and seaweed in place – take a photo instead

exactly where you found them.

- Gently turn back any rocks you have moved
- Tread carefully and don't trample through rockpools

Out walking...

- Leave gates as you find them and use stiles where possible
- Avoid sheep with young lambs



- Keep to obvious paths and watch your step in April to August – ground nesting birds conceal their nests amongst bracken and grass
- If you stumble across a nest or chicks by accident, leave at once to allow the parents to return. Gulls are always ready to take unguarded eggs and young
- If a bird appears agitated or aggressive towards you there may be a nest nearby, so quickly move away
- Try to avoid disturbing the island's mammals. Approach the wild ponies with caution and please don't feed them
- Keep away from seals and their pups between
 1st September until 30th November it's best to watch them through binoculars
- Using a metal detector or purposefully disturbing the ground anywhere on Lundy is not permitted.

Please report any acts of

misconduct to the Lundy Warden

- Stay safe!
- Check the weather and tide times don't get stranded
- Don't forget to tell someone where you're going

• Avoid poking or squashing soft bodied creatures

• Take care – rocks are slippery when wet or covered in seaweed.

 Avoid using nets or keeping creatures in buckets for a long time. After looking, quickly and gently return them to



Diving or snorkelling

- Avoid contact with the seabed and all marine life – watch your fins!
- Never remove items off wrecks or take wreck material from the seabed
- Avoid leaving air bubbles in caves or overhangs
- Spear fishing is not permitted anywhere
- Diving without a licence on a designated wreck site is illegal
- Crawfish (spiny lobsters) are very rare, please don't take them from the reserve.

Angling

- By law, there is no fishing or removal of any living thing within the No Take Zone see Lundy's marine zoning scheme
- Don't collect live bait from the seashore it's available in the shop
- Retain sufficient fish for personal consumption only and return all unwanted catch to the sea unharmed
- Release all wrasse species, tope, red band fish, bull huss and conger eels where they are caught
- Follow the National Federation of Sea Anglers (NFSA)
 'Recommended Retention Size Limits'
- Take home all discarded hooks, line, weights and nets these are hazardous to wildlife
- Fishing is not permitted in the freshwater ponds.
